OCTA was formed in December 1953 with sixteen theatres and has provided support to community theatres through workshops, the annual regional OCTA fests - a showcase of community theatre productions, and through our three-day Annual Conference. Ongoing activities include a newsletter published 5 times a year, a Call to Conference once a year, Script Lending Library, Guide/Respondent/Speakers Bureau, and a Resource Directory used to locate props, costumes, equipment, etc. We do this with an all-volunteer Board.

MESSAGE FROM THE PRESIDENT

It is with great honor that I have served as President of OCTA for the 2023-2024 OCTA year. Many of the goals I had put forward at the start of my term have been met, and it could not have been done without the tremendous support of the Executive Board - Susan Barzda, Jesse Bernal, Wayne Kirsch, Carissa Sloan, and Aara Wise. The OCTA board was hit hard with the sudden passing of John Falkenbach in November 2023. A long-time participant in and supporter of OCTA, John had rejoined the board and the executive committee as Secretary and head of the Administrative Division in September of 2023, after a several year break. His passing left an opening in the executive board during a pivotal year for the organization, and I cannot thank Susan Barzda enough for stepping into the role of Secretary and head of the Admin Division in December 2023.

As the following pages contain detailed reports from each division, region, and many of the OCTA board volunteers, I only want to lay out the basic tasks that I set before the board this year. At the Executive Board Retreat, I challenged each member of the executive committee with helping create and follow a detailed, 5 Year Strategic Plan for the organization that did not focus on specific, calendar-driven tasks, but rather goals for where the divisions and OCTA as a whole should be in 1 Year, 3 Years, and 5 Years.

The model I chose - borrowing from the Traction and EOS business models - began with creating a Vision Traction Organizer. The VTO first details the Organizational Focus for OCTA, keeping the vision and mission of the organization front and center for all members to see, allowing all to keep an eye on our Why. From there, the 1 Year Plan was laid out and contained 5 Bullet Points that I felt were key to keeping OCTA moving forward and overcoming the financial and organizational challenges it had been facing since the 2019 State Conference budget challenges and the 2020 Pandemic hitting our theatre community. Those 5 Bullet points became the primary focus for the entire OCTA Board over the 2023-2024 year:

- 1. A Profitable 2023-2024 Year
- 2. Revamp and Refocus State Conference (creating a clear division of tasks to be handled by the board and those assigned to conference chair, with detailed job descriptions and a budget outline)
- 3. Increase of Theatre and Individual Members
- 4. Increase in Patronage, including financial support from sponsorships and/or grants
- 5. Increase in Communication to all OCTA members, supporters, and volunteers

The 3-year plan then became:

- 1. State Conference easily falls into the Annual Budget
- 2. One additional OCTA-sponsored membership event is in place to be held annually

The 5-year plan was laid out as:

- 1. OCTA is fiscally solvent with reliable sponsorships and partnerships in place
- 2. Either a single, centralized location with a Theatre/Hotel format for State Conference, or several locations with a Theatre/Hotel format spread throughout the state to rotate the site of Conference
- 3. Start planning to host the AACT Region 3 conference in 2031, specifically Budgets, Conference Chair, Communication Plan in place
- 4. Workshops sponsored by OCTA run throughout the regions throughout the year
- 5. Physical location established for the OCTA administrative office and OCTA storage

Each division head was asked to focus on the detailed tasks and jobs that their division had, in order to bring about the five 2023-2024 goals, and drive OCTA strongly towards the 3-year and 5-year goals. To keep the board even more busy, the entire board of directors took on the role of planning the State Conference. While I cannot thank the executive committee enough for taking on and deftly handling the tasks I gave them, the 2023-2024 board year would not have been a success without Thom Ogilvie, who graciously took over the job of organizing and spear-heading the planning for the State Conference and has kept everyone on task. For the first year since 2019, every one of our 8 Regions and OCTA Jr held a Regional Festival this summer! I cannot thank enough all the regional reps for making this happen, as well as the programming division - and

specifically Sonja Hyer, Joe Barton, Wayne Kirsch, and Aara Wise - for getting OCTA Jr back up and running!

The 2023-2024 OCTA State Conference is being held over Labor Day weekend, 2024, with the Cherry Valley Hotel in Newark, OH as the host hotel, and the Midland Theatre in Newark as the host theatre. While registrations are still coming in and final details are still being planned, I can honestly state that OCTA Out Of The Box is looking to be a successful conference. Thanks to Jesse Bernal, we have many corporate sponsors in place this year - including MTI Music Theatre International, Associated Controls + Design, and Concord Theatricals. With their support, along with our patrons and conference attendees, I fully expect this conference to be profitable, bringing OCTA back into financial stability. The weekend is set to include many workshops from OCTA members and our corporate tech sponsor - 14 excerpts representing each of the 8 regions and OCTA Jr - several inductions into the OCTA Hall of Fame - late night activities meant to appeal to all attendees - and several new benefits for OCTA Patrons, including a Patron Lounge at the host theatre.

The 2024 State Conference also serves as Ohio's conference for the American Association of Community Theatres region 3 regional invite selection. During the 2022 OCTA conference, only 3 theatres had selected to participate in AACT - in 2024, at last count, there are 10 OCTA theatres participating, and Ohio is expected to have two of them chosen to represent the state at the AACT Region 3 Festival in March 2025 in Owosso Michigan!

While great strides were made this year towards the goals set forth in the VTO, there are still challenges to overcome. As costs increase, there will continue to be a need to increase support from members, patrons, and sponsors. Many of OCTA's regions are still struggling with fundraising to cover the expenses of their regionals. And the 2025 State Conference - set to be led by Conference Chair Kate Charlesworth-Miller - will be the first one with a newly defined division of conference responsibilities between the Chair/steering committee and the state board. The Conference Manual is being finalized over these next two months, and the 2025 Conference will be the key to the success of this format. I am confident that the dedication and passion of those involved in OCTA on every level will continue to drive OCTA as a whole forward, paving the way for the organization to continue to grow and meet the new demands of supporting the community theatre organization throughout Ohio and our neighboring states!

Delegate Coordinator Advocacy Conference Site Selection

Members of the Executive Committee are members of the Administrative Division; however, they also chair another division of OCTA at the same time the Administrative division meets. Motions coming from the Executive committee are brought forward for a vote by the Administrative Division.

The Admin Division reviewed their assignments and designated timelines at the OCTA Board Retreat, held October 21 and 22, 2023 at Troy Civic Theatre in Troy, Ohio. The division also reviewed additional tasks they would be taking on throughout the year in planning and running the OCTA State Conference, to be held August 30 through September 2, 2024. Secretary John Falkenbach also reviewed the long-range plan set forth by OCTA president Niccole Amersdorfer at the executive board retreat (held October 11, 2023, at Troy Civic Theatre) with the division.

In November 2023, John Falkenbach passed away suddenly. At the December 2, 2023, board meeting, Susan Barzda was voted in as secretary by the board of directors. As Susan had not been part of the initial long-range planning during the October executive board retreat, President Niccole agreed to assist her in running some aspects of the division meetings throughout the year. Susan also kept the responsibility of Policies and Job Descriptions, and the rest of the division held their assigned jobs. Kate Charlesworth-Miller was suggested to take over John's seat during the rest of the 2023-24 board year. The board approved her appointment by Niccole Amersdorfer, and Kate was assigned to the programming division for the year.

Regional Rep chair Michelle Peterson hosted Regional Rep Trainings and Regional Rep Meetings during each board meeting, whether by Zoom or in person. She worked with the Regional Reps to plan the 8 anticipated regional OCTAFests. OCTAFests were successfully held in all 8 OCTA regions during June and July 2024.

Spirit of Community Theatre chair Kevin Noll discussed nominations for the recognition at the May 2024 in person meeting. He emailed the multiple submissions from the Southwest region to the division members prior to the May 2024 meeting, and the SW recipients were selected by the division through email.

Hall of Fame chair Evan Copeland submitted a letter of resignation prior to the July 2024 in person board meeting. The nomination form was updated to be Susan Barzda's contact information, and social media posts were set asking Hall of Fame nominations to be sent to Susan at that time. The submitted nominations for admission into the OCTA Hall of Fame were reviewed at the in-person July 2024 meeting by the division as a whole, and four individuals were accepted. The inductees will be announced at the 2024 State Conference, with Michelle Peterson taking over the remaining responsibilities of the Hall of Fame chair for the rest of the board year.

Policy and Job Descriptions chair Susan Barzda tracked changes that need to be made to various policies and job descriptions throughout the year. Potential changes and additions are due to the board of directors retaining certain aspects of planning the annual State Conference from this year forward and will be finalized over the next few months.

Aara Wise, as historian, continues to collect OCTA History.

Long Range Planning was reviewed throughout the year with the executive board, as well as the board as a whole, by Niccole Amersdorfer

Linda Roll as nominations chair kept track of all board positions open and has been actively seeking nominations for the upcoming board elections, being held over Labor Day weekend during the State Conference. There will be 8 positions open - 6 three-year terms, 1 two-year term, and 1 one-year term.

Delegate coordinator Judy Berrens worked to keep the theatre delegates updated regarding OCTA throughout the year, and will coordinate the delegate annual meeting and board elections during the state conference,

The Admin Division met in person in October 2023 during the Board Retreat, and in person in May and July 2024, and via Zoom in December 2023, and January and March 2024 as part of Board Meetings.

REGIONAL REP COORDINATOR REPORT 2023-2024

In December reps met to discuss "What OCTA can do for you", and ideas for Friday night's activities related to Fraternities and Sororities were also discussed. Reps are In Charge of planning the Friday night events this year for the state conference. Discussion on a contest was also brought up. During our January Meeting Jesse Bernal met with the reps to review regional locations and dates, reported the dates of their next regional meetings, reviewed the need to get the host theatre contracts signed and sent to Aara, and to get staff assigned for door security, registration tables, to get regional programs typed and copied, and for other jobs needed for their regionals. Theatre members and delegates should get a box and collect scratch-off lottery tickets and be reminded of the need to have theatre update sheets sent in with their dues. Ideas for Friday night's activities related to Fraternities and Sororities should be planned by each region. In March we discussed the continued need for staffing and jobs at State. Informed Reps that they need to make sure their theatres know they have to ask to be entered for AACT competition BEFORE state conference. Informed the Reps that Theatres invited to state conference will have a different registration link for conference. Jesse had information to share about ordering shirts for OCTA. During the May meeting we discussed the need for board packets to be filled out this year, due to eliminating one of the speeches. Reps were reminded to get donations of lottery tickets, things for build a box, thrift store, etc. The deadline for HOF and contests was reiterated and reps were encouraged to get submissions. They also discussed the Friday night activities related to Fraternities and Sororities; each region should hold an event related to the theme. A few regions were still undetermined on what their Friday night activity would be at this time and stated they would have it prior to the next meeting so that room assignments can be placed. All regions were able to host a regional this year and have a representee excerpt coming attending the State conference.

FUNDRAISING DIVISION 2023-2024

In 2024, the Ohio Community Theater Association's VP of Fundraising, Jesse Bernal, led the efforts of a dedicated team to achieve the division's fundraising goals. The Division worked very hard this year, on many different issues. This included reviewing policies, rules, and competition forms.

We looked at responder training and compensation. One conflict with many wanting to take the responder training is the total time commitment at the State Conference. We have begun looking at alternative training methods, including an online webinar process. This option will continue to be an issue in the coming year.

Much work was put into organizing the Regional OCTA Fests. With so many local representatives not having run a festival in the past, assistance was offered for all Regions. A workshop is being considered on how to excerpt, and how to host a regional festival.

Continued emphasis was placed on the use of OCTA's Guide/Respondent program. This free resource can be used for both a season show and a festival excerpt.

OCTA Fest, Junior was organized, with it being more centrally located in Mt. Vernon. With the recent decline in participation in the Junior festival, this year is being strongly pushed for groups to take part. Otherwise, this program will need to be re-evaluated for the future.

This year also sees the AACT festival cycle occur. Theatres competing at the State Conference have the opportunity to compete for the Ohio AACT Fest title, with the right to advance to the Region 3 AACT Fest. This adds extra excitement to the Labor Day festival.

The Programming Division still has a lot of work to accomplish, as most of its charges are on-going tasks. We will continue to strive for the best in all of OCTA's programs.

I sincerely thank those committee members who worked so diligently throughout the year. Your efforts are greatly appreciated.

We have had two zoom meetings, but I anticipate more as Region III approaches in 2025.

And, I have also been asked to join the Festivals committee as a non-Board Member. In this capacity, I have already been part of zoom meetings and a zoom question and answer segment about festivals and festival preparations. There is SO much to learn about AACT and I have only scratched the surface. Looking forward to learning more and becoming more active in AACT.

RECAP 2023 ANNUAL STATE CONFERENCE *OCTA 2023 70th Jubilee, A Million Stars*

The state conference was held September 1st-4 th at the Eastgate Holiday Inn, Cincinnati. The theme was "OCTA 2023 Platinum Jubilee, A Million Stars". It was a great way to celebrate OCTA's 70th year with over 400 attendees. Each day a few decades were highlighted and activities from the period were organized.

On Saturday, the Delegates' Meeting was held at lunch, and new Board Members were elected. In the evening, the Patrons were welcomed at a special reception. Throughout the weekend, special activities with food and prizes were scheduled for the First Timers, which were well attended. Of course, there was Karaoke Roulette and Singo for the late nighters, as well as card games.

After Sunday's six excerpts, attendees had time to get out their silver and sparkle for the grand banquet. The Hall of Fame inductees were announced, a few other awards were presented, and special recognition plaques were given to the theaters who founded OCTA in 1953 and are still active after 70 years.

Each day there were special fun activities for which stars were awarded, and random opportunities to gain more stars were provided. Daily special prizes were given and the person with the most overall stars won a weekend in a Gatlinburg cabin. It was a close race, but Ruth Crowley captured the honor.

The weekend culminated in the Monday Brunch where other awards and contest winners were announced. Also disclosed were the awards for the amazing excerpts that were presented throughout the weekend. The theme for the 2024 conference was revealed as "OUT OF THE BOX". That Conference will be chaired by the OCTA Board.

We are happy to announce that the conference was a success financially, artistically, and socially. With the good attendance at the workshops, we hope that everyone learned something and perhaps made new friends over the weekend. CONFERENCE 2023 AWARDS

SECRETARY'S REPORT 2023-2024

The annual delegate's meeting was held September 2, 2023, during the annual State Conference at Holiday Inn Eastgate in Cincinnati, Ohio. The meeting was called to order by President Wayne Kirsch at 12:45 pm, with a roll call of all present via sign-in sheets. A motion to accept annual meeting minutes previously emailed was made by Judy Berrens, 2nd by John Falkenbach. Carried unanimously. Two motions to make amendments to the code of regulations were presented as a 1st and 2nd from the Administrative Division and approved by board members. They are:

- 1. Add the Admin Assistant to the list of executive board members. After discussion and time for questions, a vote was taken, and the motion was approved.
- 2. Call out the responsibilities of the Admin Assistant. Section numbers 3 and 4 were reversed and needed to be flipped. Time for discussion and questions was given and the vote was taken. The motion carried.

Annual Board Member Elections

Candidates for the board are Susan Barzda and John Falkenbach who submitted their board packets. Five persons were nominated from the floor and accepted their nominations, including Susan Metz-Guthrie, Sonja Hyer, Niccole Amersdorfer, Jesse Bernal, and Rose Roberts. Each candidate and the person they selected were given two minutes to present speeches to the delegates, then had time to answer questions from the floor. Upon completion of speeches, ballots were cast, with the results to be reported at the dinner being held on September 3rd. The annual delegates meeting adjourned at 1:21 pm.

The first meeting of the 2023-2024 board was held on September 4th at the Holiday Inn -Eastgate in Cincinnati, Ohio to hold elections for the executive board. The meeting was called to order by President Wayne Kirsch.

A motion was made by Aara Wise, 2nd by Rose Roberts to refund the \$10.00 difference between cast and crew registrations for a few theatres due to difficulty in communicating the link they should have used for registration. A vote was taken, and the motion passed with 2 abstentions.

A motion was made by Kevin Noll, 2nd by Aara Wise, to destroy the board election ballots from the Saturday Delegates meeting. Vote taken and the motion passed unanimously.

The meeting was then turned over to Nominations Chair Kevin Noll to conduct the voting. Niccole Amersdorfer was elected President, Wayne Kirsch was elected 1st VP of Programming, Carissa Sloan was voted 2nd VP of MMPR, Jesse Bernal was elected 3rd VP of Fundraising, and John Falkenbach was elected as Secretary.

The executive board met at Troy Civic Theatre in October 14, 2023 to make division committee assignments and set goals for the coming year.

The full board met in person for Board Retreat at the Troy Civic Theatre in Troy Ohio on October 21 and 22, 2023.

Full board meetings were held via Zoom December 2, 2023, January 20, 2024, and March 16, 2024. In person full board meetings were held on May 18, 2024 (at Muskingum County Community Foundation in Zanesville, Ohio) and July 20, 2024 (Crowne Plaza Columbus North in Worthington, Ohio. As of the writing of this report, all regionals have been held and OCTA Jr. will be taking place on Saturday, July 27, 2024, at the Maumee Indoor Theatre, Maumee, OH.

Regionals were held in ALL OCTA's eight regions as well as OCTA, Jr. First time since the pandemic so GO OCTA!! I was able to fill ALL 27 slots as well as three spots for State OCTA.

A huge thank you to Aara Wise and Wayne Kirsch for assisting in four regions this year due to overlap or my inability to attend. I was able to Chair North, East and West regions. Aara was Chair for Central, as it overlapped with Southwest, and Northwest since I cannot chair my own region. Wayne assisted by Chairing Northeast since it overlapped with Northwest and Southeast as I was unable to attend that regional. Also, a big thank you to Liz Latta as OCTAFest Chair in Training at the Southwest Regional. I worked closely with her, and she did an amazing job over a three-day festival. Wayne will be OCTAFest Chair for OCTA Jr. since 3B Productions, my theatre, will be one of the four participating theatres. Host theatres this year included: Footlighters Triple Locks Theatre in Coshocton (East), Liberty-Union High School in Baltimore (Central), Fremont Community Theatre in Fremont (North), Barlow Center/Hudson Players in Hudson (Northeast), Maumee Indoor Theatre in Maumee (Northwest, OCTA Jr), Rio Grande University in Rio Grande (Southeast), Princeton High School in Cincinnati (Southwest) and Lima Encore Theatre/Amil Tellers in Lima (West). The State Conference will be held in the historic Midland Theatre, Newark, OH. As of the writing of this report, a schedule of excerpts will be planned at the July OCTA Board Meeting. Written critiques will be sent next week as not all critiques have been finished at this time. I am working to get the final responses sent to me for disbursement.

I would like to express my thanks to all the responders, co-chairs, admins, Regional Reps, host sites and all volunteers who helped to make this one of the most successful OCTA Regional seasons in many, many years.

2024 REGIONAL REPORTS

Central Region

This year, the focus from Central Regional Representatives was to have a more hands on approach to our member theaters, whether that meant in our Zoom meetings, our theater visits to see shows, or by actively participating in shows.

East Region

Friends, Ohioans, Thespians, lend me thine ears. Or in this case, thine eyes. 'Tis time for another tale of a year in the East Region! Here are the highlights!

We begin in October 2023. After appointing (read: lovingly forcing) Nathan Mayse of Coshocton Footlight Players to join the ranks as a Regional Representative, the load shared between Machelle Miller (The Little Theatre of Tuscarawas County) and Christy Rahrig (Zane Trace Players) was tremendously lightened. This was especially appreciated as Machelle recovered from a life-changing surgery and Christy adjusted to the new and demanding role of Mother. Nathan was the only East Regional Representative to attend the Board retreat, but we already had a goal: secure a location for the second annual East Regional for summer 2024.

Because of physical limitations and scheduling conflicts, oftentimes it is much easier for our region to communicate via Facebook Messenger. Social media does have its positives after all! Through the month of November, the representatives and participating delegates messaged each other to secure a location for a regional and confirm a date. By the OCTA December Board meeting, we had achieved both: Coshocton Footlight Players would host the regional on Saturday, July 13, at their own home, the Triple Locks Theater.

After the holidays, a Zoom meeting was held on January 7 for the region. Four theatres were represented through their representatives and delegates: Sue Barzda (Zanesville Community Theatre), Machelle Miller (LTOTC), Nathan Mayse (Footlight Players), and Christy Rahrig (Zane Trace Players). Our next challenge was to determine what fun Friday night activity our region would provide at the OCTA state conference. Sue suggested a lip sync contest - we would provide the songs and props and give participants minutes to put together a fun and convincing performance. Brilliant!

For our first in-person delegate meeting on March 3, we selected a quaint dining place in Zanesville that truly captured the spirit of Americana: Cracker Barrel. The usual suspects (Sue, Machelle, Nathan, Christy) attended on behalf of their respective theatres and for the region. Here we discussed the impending East regional and what roles needed to be fulfilled. When not fawning over the Rahrig baby at the table, we also tried to figure out how many excerpts would be featured this year. Much like the previous year, we believed it would be two, with the only participating theatres being Little Theatre and Footlight Players. There was some speculation that Carnation City Players might excerpt, but it turned out to be mere speculation.

Because we enjoy feasting and fellowship, our next in-person meeting was held on April 28 at a dining establishment with more foreign flair - The Forum in Cambridge. Sue, Machelle, and Christy ate way too much Greek food while Nathan was recovering from an injury at home (we feasted on his behalf). Truth be told, not much had changed since the last in-person meeting, except that we tentatively knew which excerpts might be coming to the Regional. For consistency's sake, we decided to keep most of the things the same as last year - \$10 registration fee, 11:00 and 1:00 for the excerpts, done by 3:00. Should any changes be done, they would be discussed via Messenger.

Lo and behold, we did not meet again until the regional itself on July 13. So Messenger, emails, and possibly one carrier pigeon were used effectively to communicate what was still needed, finalize details, and make confirmations on what was accomplished. Machelle handled collecting the excerpt information to send off to our responders, Nathan worked on getting his home theatre ready to host, and Christy worked on programs. Having our regional near the end of the lineup was beneficial for us to better prepare for our day. Slight changes were made the week before, but being the true theatre folk we are, we're flexible.

It was a sunny, yet ungodly hot July morning when we hosted our 2024 East Regional at the Triple Locks Theater, Coshocton, Ohio. The air conditioning was a blessing for all attendees. And what cheerful attendees we had! In total, we had 47 at our regional, 39 of which were paid attendees. To help accommodate those with evening commitments, we moved everything earlier in the day. Our first excerpt began at 10:00, & our second excerpt was at 11:00. Coshocton Footlight Players were generous enough to provide a free lunch for everyone there!

While the responders fulfilled their responding duties, the regional representatives held their delegate meeting. Sue (ZCT), Machelle (LTOTC), Nathan (CFP), and Christy (ZTP) were present. We finalized details on how to pull off our lip sync contest for State, and we determined the Three Musketeers would stay on board as the East Regional Representatives. This is partially because no one else has yet to reach out to join us in our efforts.

Before excerpt awards were announced, a Spirit of Community Theatre Award was given (in surprise) to Mary Maxwell from The Little Theatre of Tuscarawas County. While we're on this tangent, we should also acknowledge our OCTA scholarship winner from the East as well - Abby Cox. In another first, OCTA decided to offer grant money to theatres in need for any expenses, and Zane Trace Players was awarded \$200 to help cover the royalties of their summer children's show. Even if our excerpts are few, the East region is still recognized in other capacities on the state level!

"The Glass Menagerie" from The Little Theatre of Tuscarawas County was selected to attend the State Conference, with "Sylvia" from Coshocton Footlight Players chosen as the alternate.

Our region continues to grow each year, with the addition of Roving Rogue Productions from Massillon being approved to join the ranks as of the July 20 OCTA Board meeting. Sue, Machelle, Nathan, and Christy are the backbone of the East region - without their time, talent, and treasure, the East region would not be what it has become in the last five years since its establishment. We are very proud of the work we contribute to keep our momentum going and cannot wait to continue telling our tale for years to come!

Northwest Region

The Northwest Region had a successful 2023-2024 season. The Regional Reps met to plan the year in January, and we had our first delegate meeting virtually on March 9th with several theatre delegates present. We had 2 new theatres become OCTA members – Sylvania Youth Arts Theatre and Stone Productions (a returning member after several years), but lost Children's Theatre Workshop, RAM Drama, and Maumee Valley Civic

Theatre. The first two theatres chose not to renew due to different viewpoints (not wanting to focus on the competition), but the latter had a check bounce and could not be reached to fix the payment.

We had our second meeting virtually on April 27th to discuss upcoming Northwest OCTA regional needs, such as rights, payments, and a reminder that the next delegate meeting would be at the regional on June 22. Our walk the stage was on June 8 and was attended by 8 out of 10 participating theatres. The Northwest Regional was held between June 21-22 at the Maumee Indoor Theater and featured 9 theatres – 3B Productions, Actors Collaborative Toledo, Black Swamp Players, Oregon Community Theatre, Stone Productions, The Toledo Repertoire Theatre, The Village Players Theatre, Waterville Playshop, Williams County Community Theater. Unfortunately, Fort Findlay Playhouse had to withdraw two days before the regional due to cast illness. When the responders were adjudicating the performances and printing certificates, the delegate meetings were held in the black box portion of the Indoor and was attended by nearly all delegates. We discussed some of the challenges that theatres were facing in the region, and how we could better work together. A grant writing workshop was suggested, as well as an online calendar for all OCTA theatres to use so we can be better stewards of local theatre. Zach Montri, Abby Kruse and Eve Barman were voted in as new regional reps. After expenses (theatre rental, responder hotel costs, and responder meals) were taken from the gross income, the Northwest Region made a profit of approximately \$200 from the Regional. The theatres chosen to move onto the State Conference were 3B Productions (Bright Star), Black Swamp Players (Puffs), and Williams County Community Theater (Love/Sick). The Toledo Repertoire (Amadeus) was chosen as the Alternate. The next delegate meeting will be held on August 3rd to discuss the State Conference, grant writing, and theatre collaboration (potentially using a card/app prize system to encourage attending more shows).

The Regional Reps met again on July 6 to discuss what went well and what could have been better at the Northwest Regional. They were pleased with how smoothly things ran (minus one or two technical issues) and that a profit was made. Ideas were discussed on how to make the 2025 Regional even better. They plan on renting the Maumee Indoor Theater again in June and have been in contact with the employees to book dates for the Regional itself and walk the stage.

Lastly, Evan James Copeland and Liz Latta will not be continuing as Regional Representatives for the 2024-2025 season. Evan will be moving out of the area, and Liz was recently elected as Waterville Playshop's Business Trustee and plans to focus on fundraising efforts.
